

Privacy Statement

This website (the "Website") is operated by TavTech Ltd. ("TavTech"), with its registered office Ha'azmaut 40, Yehud, Israel. TavTech respects the privacy of visitors to this Website and other persons with whom we interact ("you" or "Data Subjects") as detailed herein below. TavTech created this Privacy Statement to provide you with information about our practices regarding the collection, use, and disclosure of information about Data Subjects.

This Privacy Statement applies to information collected on this Website or otherwise in connection with the use of the Website and/or the provision of our Products (as defined in TavTech's Terms of Use) ("TavTech Products"). If you are only viewing this Website and do not intend on actively submitting information to TavTech, please note that some of the provisions below may not apply to you. We made our best efforts to provide you with clear information relating to the aggregation and use of your information, however, please contact us if you require any further clarification.

Please read this Privacy Statement carefully. By using this Website or otherwise proceeding with your interaction with the TavTech after been referred to this Privacy Statement, you hereby acknowledge that you understand and agree (where such agreement is requested or required under the applicable law) to the terms of this Privacy Statement.

TavTech will occasionally update this Privacy Statement to reflect company and Data Subjects' feedback as well as following any legal or regulatory requirements. You shall be bound by any such revisions and therefore responsible for periodically reviewing this Privacy Statement to be informed of how your information is being handled.

1. COLLECTION OF YOUR INFORMATION

1.1 Personal Information:

TavTech, and/or any of our distributors, business partners etc. may receive and collect information that you may submit on the Website's "Contact" page. Such information shall include Personal information, such as your e-mail address, full name, telephone number, country and any other information you willingly submit under the "comment" field. You hereby acknowledge that you are personally liable for any information you submit on the Website and warrant and represent that all such information is true and reliable.

The purpose of collecting this information is, among others, to:

- deliver TavTech Products to you pursuant to your request;
- interact with you and provide or procure responses for comments, questions and requests if submitted by you on the Website otherwise made;



- operate the Website;

1.2 Non-Personal Information:

Tavtech may collect non-personal information about you, including, but not limited to, the following:

- Where applicable, we may receive or collect the above and/or other information from third parties such as our web and analytical services providers; If you have been contacted by us without having provided your contact information to us, we may have lawfully obtained the above and/or other information from other third parties such as "yellow pages" or other publicly available registries, referrals, data suppliers, or our distributors or business partners that may identify you as a lead or potential client.

1.3 Collection of Anonymised Data through the Website:

TavTech collects, *via* the Website, anonymous information, such as information about your computer hardware and software that is automatically collected by the Website, including, but not limited to, browser type, domain names, access times and referring Website addresses. This information is used by TavTech for the operation of TavTech Products and applicable services, to maintain quality of TavTech Products and applicable services, and to provide general statistics regarding use of the Website.

3. USE OF COOKIES

3.1 General

The Website uses "cookies". A cookie is a small piece of data transferred to your browser by a web server, while the user is browsing. It is used to enable websites to improve user experience or to provide information to the owners of a website, or other third parties which receive data obtained from that website.
